A. Alan Hawman, 203 Main Street, Volunteer for Emmaus Heritage Alliance. Mr. DeFrain stated that the annual Emmaus Borough Volunteer of the Year Award was created to recognize those outstanding community volunteers whose unselfish and dedicated service to an Emmaus organization have made a significant difference in the community. Mr. DeFrain presented the 2016 Volunteer of the Year Award to Mr. Richard Farmer. He stated that Mr. Farmer has lived in and has been volunteering in the community for over 40 years and has volunteered with Faith Presbyterian Church, the Emmaus Arts Commission, the Emmaus Heritage Alliance and the Friends of the 1803 House. Mr. Farmer thanked Council for the award.

Janet Rader, Project Chair, Emmaus Arts Commission Student Art Award, presented the Emmaus Arts Commission Student Art Award to Laura Hodes, including a \$250.00 Dick Blick Gift Card, and a \$250.00 Gift Certificate to Conversational Threads. Ms. Rader stated that during an AP Studio class at Emmaus High School, Ms. Hodes created a series of fiber art works using felt and needles. Ms. Hodes will continue her education in the field. Ms. Hodes thanked her teacher, Katie Fenninger, for teaching her the art of needle felting. Mr. Labenberg thanked Ms. Rader for the presentation, the Art Commission for its community involvement, and congratulated Ms. Hodes for winning the award.

COMMITTEE REPORTS

a. Public Works Committee

Mr. Brown reported that the Committee met on June 12, 2017 at 3:00 p.m. He stated that the Committee discussed the 10th Street Culvert project in length. He stated that PennDot has required that the Borough Engineer conduct an additional geostudy of soil and footing tests. The results of the new soil test include that the soil is not stable enough for the culvert and the culvert will need to be redesigned to meet the PennDot requirements for this type of soil failure. The study will increase the cost of the project by at least \$50,000. Mr. Brown stated that due to the increase in the cost of the project, all other road projects will be placed on hold.

Mr. Brown reported that a 2^{nd} round of bid advertising for the bucket truck has begun. If there are no bids received, the Borough will be able to purchase a used truck from an individual or a dealer.

b. Health, Sanitation, and Codes Committee

Mr. Shubzda stated that the Committee met on June 15, 2017. The Committee reviewed the sample Ticketing Ordinance from another municipality. Mr. Pepe will begin drafting the Ordinance with Mr. Farnsworth for discussion at the July 13, 2017 Committee meeting.

c. Parks and Recreation Committee

Motion by Mr. Anders, seconded by Mr. Shubzda to hire Annika Gally, Kutztown, at an hourly rate of \$8.25 and Caleb Snyder, Emmaus, at an hourly rate of \$8.25 as part-time lifeguards at the Emmaus Community Pool. There were 7 ayes. Motion carried.

Motion by Mr. Anders, seconded by Mr. Barrett to grant the Lions Club's request to install a flag pole and light at the Lions Playground and Ballfield. There were 7 ayes. Motion carried.

d. Public Safety Committee

Motion by Mrs. Gilbert, seconded by Mr. Shubzda to hire Colin Brown as a parttime EMT for the Emmaus Ambulance Corps at an hourly rate of \$13.97. There were 7 ayes. Motion carried.

e. General Administration Committee

Motion by Mr. Barrett, seconded by Mrs. Gilbert to enter into a ten-year Lease Agreement with the Knauss Homestead. There were 7 aves. Motion carried.

Motion by Mr. Barrett, seconded by Mr. Brown to enter into a Lease Agreement with the East Penn Neighbors helping Neighbors for the property located at 151 E. Minor Street with rent being \$1,000 per month in 2018 and \$1,020 per month in 2019, and all other terms remaining the same. There were 7 ayes. Motion carried.

Motion by Mr. Barrett, seconded by Mr. Anders to enter into a draft Lease Agreement with the Seven Generations Charter School, located at 33 E. Minor Street, contingent upon final review and modification by the Solicitor. There were 7 ayes. Motion carried.

Mr. Labenberg stated that the rent at the end of the 5th year will be \$228,000, which is a significant increase and will be beneficial to the Borough.

Motion by Mr. Barrett, seconded by Mrs. Gilbert to approve the Contractual Agreement with the Emmaus Police Officer's Association for the K-9 Officer pay. There were 7 ayes. Motion carried.

Solicitor Dimmich explained that the Agreement will bring the Borough into conformance with the law.

Motion by Mr. Barrett, seconded by Mrs. Gilbert to approve the 45 day review period for the Southwestern Lehigh County Comprehensive Plan. There were 7 ayes. Motion carried.
