Mr. Labenberg reported that the Committee met on May 3, 2012. He also reported that there were 6 Personal Appeals concerning multi-unit services charges. Mr. Labenberg reported that the Committee will continue to discuss the matter. He also reported that the item will be discussed during the 2013 Budget process.

b. Health, Sanitation, and Conservation Committee

Mr. Shubzda reported that the Agenda incorrectly states that the Committee met on April 20, 2012. The Committee recommends appointing Jessica Mauro to the Joint Environmental Advisory Council.

Motion by Mr. Shubzda, seconded by Mr. Labenberg to appoint Jessica Mauro to the Joint Environmental Advisory Council to a term expiring 3/7/2013. There were 6 ayes. Motion carried.

Mr. Labenberg commented that Cintas is listed on the Agenda under three different Committees and asked if he could remove the item from his Agenda. Mrs. Gilbert responded that the item will be handled by the Health, Sanitation, and Conservation Committee.

Mr. Labenberg reported that the Committee recommends reappointing Michelle Steiner to the Special Entertainment Commission. Mrs. Gilbert responded that Ms. Steiner's current term does not expire until June 7, 2012. Council can reappoint her at that time.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant Rodale's request to rent the Emmaus Community Park Pool on Mondays, Wednesdays, and Fridays from 7:00 a.m. to 8:00 a.m. from May 30 to August 31, 2012. There were 6 ayes. Motion carried.

Mr. Labenberg stated that Rodale will pay \$25.00 per rental session and \$12.50 per session per lifeguard. Mr. Brown asked how many lifeguards are used per session. Mrs. Gilbert reported that there is one used per session.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant a pavilion fee waiver request to Karen Poshefko for May 9, 2012 from 6:00 p.m. to 7:30 p.m. There were 6 ayes. Motion carried.

Mr. Labenberg reported that the Borough is still looking for a vendor to run the concession stand at the Emmaus Community Pool.

Mr. Labenberg reported that the Committee discussed several proposed changes to the current Park rules concerning pets and bikes in Borough parks.

The next Committee Meeting is June 5, 2012.

d. <u>Public Safety Committee</u>

Mrs. Gilbert reported that on May 7, 2012, the Committee met in Executive Session for the purpose of conducting Emmaus police officer interviews. At this time, the Committee is not making a formal recommendation.

Mrs. Gilbert reported that the Committee recommends hiring Christopher Lubenetski to the Emmaus Fire Department contingent upon his passing a physician's examination.

Motion by Mr. Barrett, seconded by Mr. Brown to hire Christopher Lubenetski to the Emmaus Fire Department contingent upon Mr. Lubenetski passing a physician's examination. There were 6 ayes. Motion carried.

Motion by Mr. Barrett, seconded by Mr. Labenberg to hire Gina Hausman as a part-time paramedic to the Emmaus Ambulance Corps at an hourly rate of \$19.54. There were 6 ayes. Motion carried.

Mrs. Gilbert reported that the Meeting scheduled for Thursday, May 10, 2012 will be cancelled.

e. General Administration Committee

Mr. Labenberg reported that the Committee has a Personal Appeal from Robert Vaughan concerning the Business Privilege Tax. He also reported that the Committee discussed future Council Meeting schedules and made a recommendation to cancel the July 2, and August 6, 2012 Council Meetings with the stipulation that Christine Snyder shall be authorized to pay the normal course of business bills. Mr. Pepe and Mrs. Gilbert will also work to send matters directly to committees during periods when the Council Meetings are cancelled.

Mr. Labenberg reported that the Committee discussed the Resolution to create the Junior Council Program in the Borough of Emmaus. The Committee will interview interested Junior or Senior High School candidates and hopefully have a candidate by the end of summer.

Motion by Mr. Labenberg, seconded by Mr. Brown to adopt Resolution 2012-12 – A Resolution of the Emmaus Borough Council Authorizing Participation in the Pennsylvania State Association of Boroughs Junior Council Person Program. There were 6 ayes. Motion carried.

Mr. Labenberg reported that the Committee discussed the installation of a PPL Pole at 152 E. Main Street to alleviate a safety issue. The Committee recommends that Council approve the request by PPL to place a pole on the property located at 152 E. Main Street, with the stipulation that Mr. Pepe and Mr. Clapper communicate to PPL that if any trees are affected, PPL shall plant a new tree on the property.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant PPL's request to place a telephone pole on the property located at 152 E. Main Street, with the stipulation that Mr. Pepe and Mr. Clapper communicate to PPL that if any trees are affected, PPL shall plant a new tree on the property. There were 6 ayes. Motion carried.

Mr. Labenberg reported that the Committee discussed Facebook and drafting a proposed social media policy. Mr. Brown asked if the Borough needs a Facebook page. Mr. Pepe stated that the Special Entertainment Commission requested the Facebook page and it is very useful as an informational tool. Mr. Barrett stated that it is an especially useful tool to advertise events to younger people.

Mr. Holtzhafer reported that the Committee had a Personal Appeal from Mr. Vaughn, 530 E. Greenleaf Street, concerning the Business Privilege Tax. Mr. Vaughn

believes that the Business Privilege Tax is excessive for his personal economic situation. Solicitor Dimmich stated that under the Local Tax Enabling Act, the Borough does not have the power to waive a tax. Mr. Pepe responded that the current Borough Ordinance states that the only way to waive the Business Privilege Tax is if the person proves they do not own a business or if the business is a 501c (3).

Mr. Holtzhafer reported that the Borough will forward its request to the General Authority. The items the Borough will request are:

Mr. Holtzhafer reported that the 2012 Budget for the First Quarter is on target. Mr. Pepe has reviewed the First Quarter with the Department Heads.

He and Mrs. Gilbert will be submitting the 2012 CDBG application on behalf of the Borough of Emmaus.
