# g. Community Relations, Planning and Development Committee

Mr. Brown reported that the Committee met on May 24, 2012. Mr. Brown reported that the deadline for the VFW Pocket Park Project is June 30, 2012. The project will include benches, planters, and a flag pole. The flag pole, which has an estimated cost

of \$2,050, is a donation from the Koltisko family. Mr. Brown reported that the projected cost is approximately \$12,000. The estimated cost for the Borough is \$4,000.

Mr. Brown reported that the Tree Vitalize Project's deadline is June 30<sup>th</sup>. The total project cost is approximately \$800. The Borough will receive reimbursement from the DCNR of approximately 66%. The Borough will pay approximately \$272 for 7 trees. Mr. Brown reviewed pictures of the Bradford Pear trees that will be replaced. There are two Bradford Pear trees located in front of the VFW, one in front of Wentz Hardware, and one at the corner of Cherry Street and Main Street. Mr. Brown reported that the trees have been removed by the Public Works Department and the new trees will be planted as weather permits. The trees being planted are Okami Cherry Trees. These are the same species as the trees that were planted on the Broad Street islands.

Motion by Mr. Brown, seconded by Dr. Waddell to plant four Okami Cherry Trees, two in front of the VFW, located at 316 Main Street, one in front of Wentz Hardware, located at 225 Main Street, and one at the corner of Cherry Street and Main Street. There were 7 ayes. Motion carried.
