PERSONAL APPEALS, PART I

A. Kim Lowmaster, 1049 Arch Street – voiced concern about Verizon placing a pole at Arch Street, between 10th & 11th Streets. Mrs. Gilbert responded that she will discuss the matter with Mr. Pepe.

B. Rick Zayaitz, Emmaus Main Street Partners – requested a pavilion fee waiver for the use of the Lion's Club and North Pavilions for a Clam Bake to be held on Sunday, July 29, 2012. Mr. Barrett responded that the item was handled at the Committee level and that the Committee did not make a motion to waive the fee.

COMMUNITY MINUTE

Mr. Barrett thanked Mr. Brown for the Flag Pole dedication in front of the VFW building on Sunday, July 15, 2012. Dr. Waddell thanked the Koltisko family for dedicating the pole at the VFW pocket park and thanked Mr. Brown, Mr. Clapper, and Mr. Pepe on their efforts for completing the park by its deadline of June 30, 2012.

Dr. Waddell stated that the rain barrels being auctioned by the Emmaus Arts Commission have received several bids and the winners will be announced during Community Day to be held on July 21, 2012 at Emmaus Community Park.

Mr. Labenberg noted that another loop was added to the South Mountain Trail connecting to the current trail. Mr. Barrett stated that a kiosk is being built and that Rodale has again helped to make the second trail possible.

Mrs. Gilbert reminded everyone that the August 6, 2012 Budget & Finance Committee and Borough Council Meetings have been cancelled.

SOLICITOR'S REPORT

Solicitor Dimmich entertained questions about his report. He reported that the Main Street Partners Agreement has been approved. He also reported that he will continue to work on the Conservancy Trailhead Easement Agreement. He stated that it is very important to delineate the future maintenance responsibilities of the parties. Mrs. Gilbert directed Mr. Barrett to place the item on the Parks and Recreation Committee's Agenda. Solicitor Dimmich encouraged Council to read the Cintas Memorandum included in his report.

UNFINISHED BUSINESS, PART I

Ordinance No. 1085 – An Ordinance Establishing a Tree Fund, and Authorizing the Emmaus Shade Tree Commission to Collect Money in Lieu of Requiring the Replacement of Trees (1st Reading 3/19/12) (Tabled 3/19/12) (1st Reading 6/18/12) (2nd Reading 7/16/12).

Motion by Mr. Labenberg, seconded by Dr. Waddell to read Ordinance No. 1085 in Short Title. There were 5 ayes. Motion carried.

Dr. Waddell noted the original draft of the ordinance required the property owner to make a payment into the Tree Fund in the amount of \$450.00. This version requires a \$200.00 payment. He stated that he believes \$200.00 will only cover the cost of the tree, not the cost of the tree plus installation. Mr. Labenberg noted that Paragraph 3 has standards that were not included in the original draft. Mr. Labenberg stated that he was originally opposed to the Borough getting involved with trees on private property if they did not pose a danger but supports this Ordinance and believes it provides the residents more options.

Motion by Mr. Barrett, seconded by Dr. Waddell to adopt Ordinance No. 1085 - An Ordinance Establishing a Tree Fund, and Authorizing the Emmaus Shade Tree Commission to Collect Money in Lieu of Requiring the Replacement of Trees on its 2nd Reading. Roll call vote: Mr. Labenberg, aye, Mr. Barrett, aye, Mr. Shubzda, aye, Dr. Waddell, aye, Mrs. Gilbert, aye. There were 5 ayes. Motion carried.

Motion by Dr. Waddell, seconded by Mr. Barrett to read Ordinance No. 1086 in Short Title. There were 5 ayes. Motion carried.

Mrs. Gilbert read Ordinance No. 1086 in Short Title.

Motion by Dr. Waddell, seconded by Mr. Labenberg to adopt Ordinance No. 1086 - An Ordinance Authorizing and Establishing Attorney's Fees for Collection of Municipal Liens and Tax Liens and Establishing the Rate of Interest on its 2nd Reading. Roll call vote: Mr. Shubzda, aye, Dr. Waddell, aye, Mr. Labenberg, aye, Mr. Barrett, aye, Mrs. Gilbert, aye. There were 5 ayes. Motion carried.

Dr. Waddell explained that the Borough will not be involved in collecting money from residents with liens placed on their property and will allow the attorney to bill the property owner for their time spent collecting past due money. Solicitor Dimmich explained that it is a procedural change and believes it will save resident's money because the Borough will not have to spend tax dollars collecting bills from liens. He cautioned, however, that the Ordinance will make it more expensive for a resident to remove a lien from their property if one is placed from lack of payment.

NEW BUSINESS – None.

UNFINISHED BUSINESS, PART II

Ordinance No. 1037 – An Ordinance Amending the Provisions of Chapter 2, with the Addition of Sections 501 & 502, Prohibiting the Feeding of Waterfowl on Borough Owned Properties (1st Reading 1/7/08) (Tabled 1/21/08) (1st Reading 6/18/12) (2nd Reading 8/20/12).

Mrs. Gilbert noted that Ordinance No. 1037 is scheduled for its 2nd Reading at the August 20, 2012 Council Meeting.

ITEMS NOT ON AGENDA, subject to Rule 9 – None.

MAYOR'S REPORT

Mayor Iobst thanked Mr. Brown for his hard work with the Flag Pole dedication in front of the VFW and for his enthusiasm as a Council Member.

COMMITTEE REPORTS

Mrs. Gilbert stated that Chief Faust is present and moved a portion of the Public Safety Committee Report ahead of the other Committee Reports. Mrs. Gilbert reported that the Committee recommends bringing forth a non-budgeted item. The Committee

recommends that Council approves the purchase of new firearms for the Emmaus Police Department. Chief Faust stated that the existing weapons used by the Department are 13 years old and have been fired a minimum of 500 times per year during training and qualifications. He also stated that four of the aging pistols have had mechanical errors in 2012 raising serious concerns about the reliability and safety of the weapons. The guns currently in use by the Department are lacking night sights. He reported that the Department received 3 quotes, and that it will cost approximately \$12,600 to refurbish and add night sights to the weapons currently used. The pistols, magazines, accessories and two new Sig Sauer M400 M4 tactical rifles will cost \$16,789.70. Chief Faust stated that the items were proposed in the 2011 and 2012 budget but were not included due to budgetary cuts. Mr. Labenberg thanked Sergeant Schantz for his research in preparing the proposal.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant the Emmaus Police Department approval to purchase Service Pistols, Non-Uniformed Pistols, Holsters, Pouches, and Additional Magazines, Rifles, and Grips in the amount of \$16,789.80. There were 5 ayes. Motion carried.

Mrs. Gilbert reported that the Committee recommends that the Emmaus Police Department leases a computer server. Chief Faust explained that the new system will allow 25 users to be on the system at one time compared to the current server which only allows five. The current server continues to suffer serious crashes when officers attempt to use their vehicle computers while administrators use the system from the station. The total lease of the computers will cost approximately \$2,000 more than purchasing the system outright, but will include maintenance, which can sometimes cost up to \$1,000 per incident.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant a four year lease agreement between the Emmaus Police Department and Integra I for a computer server at a cost of \$581.55 per month.

Mr. Labenberg amended his motion, and Mr. Barrett amended his second.

Motion by Mr. Labenberg, seconded by Mr. Barrett to grant a four year lease agreement between the Emmaus Police Department and Integra I for a computer server at a cost of \$581.55 per month subject to Solicitor Dimmich's approval of the Agreement. There were 5 ayes. Motion carried.

a. Public Works Committee

Mr. Labenberg reported that the Committee met on July 5, 2012. Mr. Labenberg reported that the Committee discussed the MXU program and Mr. Clapper stated that approximately 75% of the Borough's water meters have been converted to electronic

meters. Mr. Labenberg also reported that Mr. Pepe indicated that there may be Growing Greener funds available to help fund the rest of the program. Mr. Labenberg reported that Mr. Clapper and Mr. Pepe met with William Ahlert and Solicitor Dimmich on July 9 to discuss Cintas. Solicitor Dimmich prepared a memorandum addressing the issue. Mr. Labenberg reported that the Committee discussed the S. 10th Street Culvert and Mr. Clapper will obtain an update from the Borough engineer regarding the design of the culvert. There is a small sinkhole forming. Mr. Clapper suggested opening the hole and filling it again.

Progress.

b. Health, Sanitation, and Conservation Committee

Mr. Shubzda reported that the Committee will meet on July 20, 2012. Mr. Shubzda reported that there is a sample recycling container at Town Hall and encouraged everyone to look at it. He noted that the lid on the recycling container is blue, but the lid color will be green. The containers will be placed at parks throughout the Borough.

Progress.

c. Parks and Recreation Committee

Mr. Barrett reported that the Committee recommends appointing Peter Gasper to the Parks and Recreation Commission.

Motion by Mr. Barrett, seconded by Mr. Labenberg to appoint Peter Gasper to the Parks and Receptions Commission to a term expiring 5/1/2015. There were 4 ayes, 1 abstention (Barrett). Motion carried.

Mr. Barrett reported that the Committee recommends appointing Terri Gasper to the Special Entertainment Commission.

Motion by Mr. Barrett, seconded by Mr. Labenberg to appoint Terri Gasper to the Special Entertainment Commission to a term expiring 6/7/2014. There were 4 ayes, 1 abstention (Barrett). Motion carried.

Motion by Mr. Barrett, seconded by Mr. Shubzda to appoint Paulette Labenberg to the Special Entertainment Commission to a term expiring 6/7/2013. There were 4 ayes, 1 abstention (Labenberg). Motion carried.

Mr. Barrett reported that the Summer Parks Program is a huge success with 97 kids signed up for the Program. The Committee recommends hiring an additional counselor to the Program.

Motion by Mr. Barrett, seconded by Mr. Labenberg to hire Colin Farrell as a Summer Parks Counselor at an hourly rate of \$7.25. There were 5 ayes. Motion carried.

Mr. Barrett reported that there was a Summer Parks Counselor that took employment elsewhere. Mr. Pepe appointed Tyler Silfies on a temporary basis.

Motion by Mr. Barrett, seconded by Mr. Labenberg to hire Tyler Silfies as a Summer Parks Counselor at an hourly rate of \$7.25. There were 5 ayes. Motion carried.

Mr. Barrett reported that Emmaus Community Day will be held on Saturday, July 2, 2012, with many events being held. He encouraged everyone to attend.

Mr. Barrett also reported that the Emmaus High School rifle team is losing its rifle range facility, due to its closure. Mr. Labenberg has been working with Chief Faust for several months regarding the possibility of the rifle team using the Borough's rifle range for competition. Mr. Barrett stated that the Committee recommends that Mr. Pepe begin negotiations with the Emmaus High School Athletic Director. Mr. Labenberg explained that the motion is for Mr. Pepe to begin negotiations and an Agreement will be brought forth to Full Council.

Motion by Mr. Barrett, seconded by Mr. Labenberg to allow Mr. Pepe to enter into negotiations with the Athletic Director for the purposes of the High School Rifle Team to use the Borough shooting range for competition purposes. There were 4 ayes, 1 abstention (Labenberg). Motion carried.

Mr. Barrett stated that Ordinance No. 1037 – Geese at Furnace Dam is scheduled for its 2nd Reading at the August 20, 2012 Council Meeting.

Mr. Barrett reported that the next Committee Meeting is August 7, 2012.

Progress.

d. Public Safety Committee

Mrs. Gilbert reported that the Committee met on July 12, 2012. Chief Reiss recommends appointing Derek Martino as a member of the Emmaus Fire Department.

Motion by Mr. Barrett, seconded by Dr. Waddell to appoint Derek Martino as a member of the Emmaus Fire Department contingent upon passing a physician's physical. There were 5 ayes. Motion carried.

Mrs. Gilbert reported that Chief Reiss recommends appointing Gabriel McNabb to the Emmaus Fire Department as driver of Trucks 711 and 712.

Motion by Mr. Barrett, seconded by Dr. Waddell to appoint Gabriel McNabb to the Emmaus Fire Department as driver of Trucks 711 and 712 and to appoint Kurtis Knauss to the Emmaus Fire Department as driver of Truck 751. There were 5 ayes. Motion carried.

Mrs. Gilbert reported that the Committee received a request to consider placing a four-way stop sign at the corner of 5th Street and North Street. Mrs. Gilbert stated that the item was referred to the Traffic Control officer.

Mrs. Gilbert reported that the Committee received a Personal Appeal by Charles Harter, 582 Glenwood Street, concerning parking issues at Boroline Park. She reported that the Committee will address the item.

Mrs. Gilbert reported that the Tractor Trailer Parking Ordinance is scheduled for its 1st Reading at the August 20 Council Meeting. Mr. Labenberg stated that he originally supported tractor trailer parking but is now in favor of the Ordinance because the trucks are destroying the curb lines.

Mrs. Gilbert reported that the Committee held an Executive Session and recommends accepting the resignation of Frederick Bainhauer from the Auxiliary Police. At the present time, his vacancy will not be filled.

Motion by Mr. Barrett, seconded by Dr. Waddell to accept the resignation of Frederick Bainhauer from the Auxiliary Police. There were 5 ayes.

Dr. Waddell stated that he has received complaints from residents about Triangle Park concerning skateboards and individuals entering the fountain. He suggested better signage at the Park stating the Park Rules and Regulations. Mrs. Gilbert responded that the matter will be addressed.
