Council President Waddell called the meeting to order at 7:00 p.m.

PERSONAL APPEALS, PART I

- a. Charles Moniak, 152 Linden Court South, told Council that the conditions at Meadow Pool are deteriorating. The grass in the back is uncut and the pool water is starting to turn black. Mr. Moniak is concerned that the pool will attract mosquitoes and the uncut grass will attract field mice. Because of Mr. Moniak's health, he is very susceptible to infections and is concerned about the mosquitoes. Mr Neely told Mr. Moniak that he contacted our Health Inspector, Garry Ritter. Mr. Ritter coordinated with Lehigh County, which treated the pool with a chemical that will take care of the mosquitoes all summer. Jim Farnsworth, the Zoning Officer, contacted the president of the Meadow Pool Association regarding the weeds. Mr. Neely stated that if the weeds are not taken care of, the Borough will arrange to have them cut and will seek reimbursement.
- **b.** John Hayes, on behalf of his parents of 1006 Liberty Street, recognized the Ambulance Corps and Police Department for their outstanding work. His parents have used their services numerous times recently.
- **c. Bruce Carl, 136 N. Fourth Street**, referred to a zoning ordinance that allows up to four people with different last names to reside in a home. He stated that the Borough needs to specify in the ordinance that the residents living in one home do not have to have the same last names and they don't have to be family. Referred to the General Administration Committee.

MAYOR'S REPORT

Mayor Iobst reported to Council that he attended the Shops of Emmaus Best in Bloom event, and noted that it was a nice event. Progress.

COMMITTEE REPORTS

a. Public Works Committee

The Committee met on June 3 and no action is to be taken. Progress.

b. Health and Sanitation Committee

The Committee meeting scheduled for June 11 was canceled. Progress.

c. Parks and Recreation Committee

Motion by Council Member Barrett, seconded by Council Member Holtzhafer to hire Nate Clark at a rate of \$7.65 per hour and Leah Smith at a rate of \$7.15 per hour as part time lifeguards to work at the Emmaus Community Pool for the 2009 season. There were 6 ayes. Motion carried.

Mr. Barrett explained that two lifeguards who were hired on April 20 are not available to work. Since the two lifeguards that are being hired are college students and are unable to work until the end of the season, an additional two or three lifeguards, preferably high school students, may need to be hired to have coverage through the end of the season. Progress.

d. Public Safety Committee

Motion by Council Member Gilbert, seconded by Council Member Barrett to hire Timothy Steiner of Emmaus, Megan Kapun of Breinigsville, and Joshua Garloff of Emmaus to work as Auxiliary (Park) Police. There were 6 ayes. Motion carried.

All interviews were handled by Chief Faust and Officer Hamscher.

The next Committee meeting is scheduled for June 18 at 9:00 a.m. Progress.

e. General Administration Committee

Motion by Council Member Barrett, seconded by Council Member Gilbert to appoint Stephen Zakos to the Planning Commission for a term expiring April 1, 2013. There were 6 ayes. Motion carried.

Dr. Waddell explained that the Committee discussed a proposal from Aqua Duck Water Transport. According to the Memorandum from Mr. Neely dated June 11, 2009, Greg Sanders, owner of Aqua Duck Water Transport, spoke to Jeff Clapper regarding purchasing water from the Borough. They had been purchasing water from the Lehigh County Authority, but they are now prohibited from withdrawing water because of a nonessential water use ban imposed by LCA. Aqua Duck transports water to swimming pools throughout the summer. Mr. Barrett noted that Aqua Duck would be removing between 2 and 3 million gallons of water for the year. To put it into perspective, the Borough pumps an average of 1.2 million gallons of water a day. Mr. Labenberg noted that at a rate of \$4.00 per gallon the Borough would net between \$8,000 and \$12,000 as water revenue. Dr. Waddell confirmed with Mr. Sanders that their season runs into July. Dr. Waddell stated that it's a win-win situation for everyone. Attached to the Memorandum was an Agreement drafted by Mr. Neely. Mr. Labenberg noted that the Borough can discontinue the agreement at any point.

Motion by Council Member Labenberg, seconded by Council Member Gilbert to approve the Agreement with Aqua Duck Water Transport.

Mr. Brown asked if withdrawing the water from a fire hydrant would affect the quality of water dispensed to the residents. Mr. Neely confirmed that Brad Youst, the Borough's utility engineer, said that it is not a concern. It was agreed upon that Mr. Sanders will be pulling water from the hydrant located at the Rite Aid parking lot on Chestnut Street. The Borough will be flushing the area first to clean it out. Mr. Sanders agreed that he would pay for the amount of water necessary to do the flushing, which would be \$131.

Mr. Brown also asked whether, if the Agreement was approved tonight, Mr. Sanders would be able to start as soon as tomorrow. Mr. Neely replied "yes" and asked Mr. Sanders to remain after the meeting to review and sign the Agreement.

There were 6 ayes. Motion carried.

The next General Administration Committee Meeting is scheduled for June 24 at 9:00 a.m. Progress.

f. Budget and Finance Committee

Mr. Brown noted that the next Committee meeting is scheduled for June 24 at which time the Committee will be discussing the clean up request from the Seven Generations Charter School. The Committee will also be discussing volunteerism.

Mr. Brown reported that the Triangle Project is going well. He confirmed with Mr. Neely that the Project is expected to be completed in the first or second week of July.

Mr. Brown mentioned that Mrs. Tempest, 2009 Celebration Education Coordinator, showed a DVD at Jefferson Elementary School. He thanked her for the work she is doing to educate everyone about the 2009 Celebration. Dr. Waddell mentioned that a tape of Alan Hawman's walking tour of the Borough's architecture is available at the Library.

BOROUGH MANAGER'S REPORT

Mr. Neely noted the Significant Revenue and Expense Items for the first half of June 2009.

Mr. Neely explained to Council that the Department of Transportation is upgrading the traffic signals beginning in Emmaus on Cedar Crest Boulevard to Walbert Avenue. They are asking that the Borough sign an Agreement to maintain the new traffic signals that they will install at Cedar Crest Boulevard and North Street.

Mr. Labenberg asked why the light needs to be upgraded since it was only installed about 10 to 15 years ago. Mr. Neely replied that new sensors and timers will be installed as well as a function that would allow emergency personnel to be able to activate the light to change it from a red light to a green light. It would enable emergency vehicles to stop traffic on intersecting roads as the emergency vehicles pass through the intersection on a green light.

The State requires that the Borough provide a Resolution of Council authorizing the Council President and the Borough Secretary to sign the Agreement on behalf of the Borough. Mr. Neely read Resolution 2009 – 17.

Motion by Council Member Brown, seconded by Council Member Gilbert to approve Resolution 2009 - 17. There were 6 ayes. Motion carried.

PRESIDENT'S BUSINESS

Dr. Waddell thanked the Flag Day Association for its programs. Dr. Waddell recently received a request to rent a pavilion for a 35th class reunion at Community Park on August 15. However, every pavilion has been rented. To accommodate everyone, he is asking Council's approval for the 2009 Anniversary Celebration Steering Committee to allow tents to be set up in the Community Park, or perhaps ask renters to share pavilions. There would be no cost to the Borough.

Motion by Council Member Brown, seconded by Council Member Labenberg to give the 2009 Anniversary Celebration Steering Committee the authority to make the decision to allow tents or shared pavilions for class reunions during the weekend celebration on August 15 and 16. There were 6 ayes. Motion carried.

ADJOURNMENT

Motion by Council Member Holtzhafer, seconded by Council Member Gilbert to adjourn. There were 6 ayes. Motion carried.
